Report of School Directors

School directors met at North Clarendon, July 1st, and organized with Frank Teer, chairman and clerk. Each director was appointed truant officer.

Chairman reports that nearly every school is doing extra good work.

At the time of organizing we decided to paint five of the school houses inside this year and also to build new cement steps at North and East Clarendon, and to put windows in at Clarendon Springs school, and new doors at East Clarendon and Hook.

I suggest that a new stove be placed in the Clarendon Springs school, for the present one is unsafe.

If we continue to maintain a school at East Clarendon, new seats must be provided as the present ones are not suitable for any child to write on. The East Street school is in need of a new foundation. A new fence must be built at North Clarendon, between Charlie Spafford's place and the school grounds.

A tax of 85 cents is recommended.

Report of District Superintendent

To the People of Clarendon:

It is with much pleasure that your superintendent submits the report for 1922.

Last year's report asked for better instruction, improved buildings, better care of schools, better care of the children and better attendance. Clarendon's answer has been most gratifying.

First: The teachers' salaries were raised to the standard of the other towns about us. As a consequence but one teacher resigned. The result is that the progress made by the children, in most of the schools, is infinitely better.

Second: Through the efforts of your very conscientious school board, most of the buildings in Clarendon have proper foundations and good steps. The schools have been changed from dingy, uncomfortable rooms to light, cheerful homes. In four of the buildings the old shades have been replaced by permanent adjustable shades, second in quality and durability to none in the state. Clarendon schools are being used as an illustration of the right type of shades for school buildings.

The Springs school has been greatly improved by the removal of trees, which obstructed the light, and by the addition of several windows.

Third: The teachers and children work together to keep the school property looking at its best, and the best of it is, that the spirit of co-operation is fine.

Fourth: The attendance is somewhat better, but is still in need of attention from the parents.

PROBLEMS FOR 1922

The state has issued plans for the standardization of rural schools—these plans include very definite instructions for proper placing of windows, coatrooms, toilets, for proper equipment and for grading of grounds and play ground. The State Board

of Education promises to refund any amount, up to \$200.00, expended by the town, provided the plans for expenditure are first submitted to the state officials and approved by them. Most of the buildings in Clarendon would admit of standardization, without any great expense. If the Mother's clubs with their fine spirit of determination, would take over the problem of raising money for the changes in the buildings, and the fathers of each district would take up the matter of grading the grounds and providing the play ground equipment, we could soon have standardized schools and that without raising the tax one cent.

Every school building in Clarendon can be made into a beauty spot, a place that will be a matter of pride to the people of the district and that at small cost, provided every one is interested enough to help. Your Superintendent's offer of a prize to the first school to standardize is still open.

The buildings should be painted on the outside this year.

It is with heartiest thanks for the splendid work done by school directors, teachers, children and Mother's clubs, that your Superintendent submits her report.

Report of Health Officer

The following communicable diseases have been reported from Clarendon: Measles 18, Scarlet Fever 5, German Measles 1, Whooping-cough 38.

During the year 120 pupils have been inspected, of which 64 have been found defective. Of these defective, 53 had defective teeth, defective vision 9, throat 11, mentally defective 1, defective heart 1, skin disease 1.

Clarendon should take steps to make at least one school house comply with the State Board requirements each year. In this way the burden is not felt and the school houses are made to come up to standard. Many towns are doing this and it works very well indeed. In repairing school buildings it should be remembered that all plans must be submitted to the State Board of Health for inspection and that the plans submitted and approved must be carried out. Towns who fail to do this are likely to have to go to the expense of having to do the work over again and officials responsible are liable to prosecution. There is no better advertisement for a town than good schools, in good school buildings. It keeps the good citizens who would otherwise move away to educate their children and draws desirable citizens to the town. It thus increases the value of real estate.
