(ECF No. 175 at 8-9.) While the putative John Doe has not yet identified a single legal authority entitling him to attorneys' fees on appeal, Movant nevertheless respectfully submits that the putative John Doe's appeal bond may now be reduced by \$90,000—an amount that reflects the consolidation of the six appeals beyond the original appeal (or as the putative John Doe puts it, \$15,000 x 6). (Id.) The Court should enter an order reducing the amount of the appellate bond to \$45,585.66. Movant has conferred with the other individuals subject to the bond order and has received their consent to the relief sought in this motion. Pietz objects to the relief sought herein. Movant was unable to contact Gibbs. Further, Movant is using Pietz's own calculations. In light of these facts, Movant respectfully submits that the Court should grant this motion.
